- Bank reference letters must be originals and on letterhead. Copies of reference letters must be notarized. Reference letters should attest to the subject's good character and must confirm at least 2 years of satisfactory business and/or personal dealings. Letters must be signed and include a contact name and number. Letters may be addressed "To Whom it May Concern". Stock USA may at its discretion verify references on an anonymous basis.
